*In pursuance of* the Office Order No. DNGC/CDC/SPORTS COMPLEX/2026/1561 dated 07<sup>th</sup> May 2026, issued by the Office of the Principal, Dera Natung Govt. College, Itanagar, the College Development Committee (CDC) has been entrusted with the overall supervision, operation, regulation, and management of the Multipurpose Sports Complex (Badminton-cum-Judo Hall) of the College with immediate effect.

The Multipurpose Sports Complex is hereby opened for regulated institutional and public use subject to the approved Standard Operating Procedure (SOP), rules, safety protocols, and terms fixed by the College authority.

**Categories of Users**

Applications / bookings may be considered from:

1. Students of Dera Natung Govt. College
2. Faculty and Employees of DNGC
3. Employees of Government of Arunachal Pradesh / Approved Individuals

**Booking & Membership**

Interested users/groups may apply for:

- Daily Membership
- Monthly Membership
- Yearly Membership
- Tournament / Event Booking

Allotment of slots shall be made strictly subject to availability, institutional priority, maintenance requirements, and compliance with SOP guidelines.

### **Important Conditions**

1. All users shall strictly maintain discipline, cleanliness, and decorum inside the Sports Complex.
2. Users shall comply with all safety protocols and instructions issued by the CDC or authorized officials.
3. Damage to institutional property shall attract penalties and disciplinary action.
4. Consumption of alcohol, tobacco, smoking substances, or any prohibited activity inside the premises is strictly prohibited.
5. The College reserves the right to regulate, suspend, or cancel any booking in the interest of institutional functioning, maintenance, safety, or public order.
6. External events/programmes shall require prior approval of the competent authority.
7. Appropriate user charges/membership fees as approved by the College authority shall be applicable.

### **Timing**

The Sports Complex shall function as per the timings notified separately by the College authority / CDC.

### **Approved Rate Structure / Membership Fees**

To ensure regulated utilisation, maintenance, and sustainability of the facility, the following rates and membership charges shall be applicable for use of the Multipurpose Sports Complex as per the approved SOP and institutional norms:

| Category of User                            | Per Day | Per Month | Per Year  |
|---------------------------------------------|---------|-----------|-----------|
| DNGC Students                               | ₹20     | ₹500      | ₹5,000    |
| DNGC Faculty / Staff                        | ₹50     | ₹1,500    | ₹15,000   |
| Government Employees / Approved Individuals | ₹100    | ₹3,000    | ₹30,000   |
| Professional / Judo Arena Users             | ₹350    | ₹10,000   | ₹1,00,000 |

### **External Booking / Event Charges**

- Badminton Court: ₹10,000 per court per day
- Judo Arena: ₹10,000 per day

### **Payment and Usage Conditions**

1. All payments shall be made in advance.
2. Fees shall be non-refundable and non-transferable.
3. No adjustment shall be made for partial usage.
4. Yearly membership is concessional and provides approximately two months' fee waiver.
5. In case of limited availability, priority shall be given in the following order: yearly members, monthly members, and daily users.
6. The CDC may revise the fees periodically based on maintenance requirements and usage demand.

7. DNGC official sports activities and institutional tournaments shall receive priority over all other bookings.
8. Student membership and concessional student rates shall be applicable only to regular bonafide students of Dera Natung Govt. College possessing valid College Identity Cards.
9. Students may be required to produce valid ID cards during registration and at the time of entry/use of the Sports Complex.

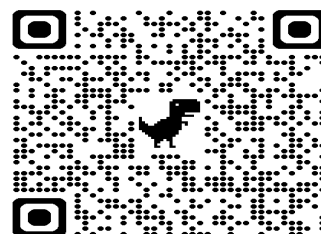
